



**2011-2012 K-6<sup>th</sup> GRADE  
SPF-PAL WRESTLING - REGISTRATION FORM**

This level is open to children from K-6<sup>th</sup> grade. This is an instructional level that also provides competitive wrestling through Central Jersey Wrestling League made up of towns primarily from our surrounding area. Both official and exhibition matches are provided based upon the child's age, weight, and skill level.

This level is divided into 2 groups: Novice Team [K-3<sup>rd</sup>] and Varsity Team [4-6<sup>th</sup>]. Upon coach's decision, some K-3<sup>rd</sup> may participate on the Varsity Team. Each team practices separately and your child will be notified which practice to attend. Practices will be held at the SPFHS wrestling room 1-2 nights per week for the Novice Team and 2-3 times per week for the Varsity Team. Both Novice Team and Varsity Team matches will be primarily on the weekends, with some weeknight matches possible. Registration cost is **\$120**. Singlet/uniform is provided. Wrestling shoes and headgear are **not provided** but are **required**.

**Applications must be received by November 20, 2011 to avoid a \$10 late fee. There is a \$25 discount for families registering two or more children.**
